- 1) All certificate orders must be placed by Presto Pay when you place your order. TAP/Scrip certificate payments are not tax deductible because you receive dollar for dollar value.
- 2) If your Presto Pay payment is returned because of non-sufficient funds (NSF), you will be charged a \$30.00 fee payable to New Covenant Christian School. After two NSF charges are tendered on your account, your scrip ordering privileges will be suspended.
- 3) TAP/Scrip certificates are purchased on your behalf and are not returnable.
- 4) When you pickup your TAP/Scrip certificates, open your order and verify its accuracy. Your signature on the weekly order pickup list indicates you have received your order in its entirety.
- 5) TAP/Scrip certificates are the same as cash, and should be handled accordingly. New Covenant Christian School will not be responsible for certificates that are lost, stolen or misplaced while in your possession.
- 6) You must sign a WAIVER OF RESPONSIBILITY form before certificates will be released with your child or other person other than the person who placed the order. These forms will be kept on file, and New Covenant Christian School accepts no responsibility for certificates delivered in this manner.
- 7) Please remember that there is a 1% threshold deduction of the gross order amount to cover the cost of administering the program.
